

KraneShares Asia Pacific High Income USD Bond ETF*

Investment Strategy:

KHYB is an active ETF managed by sub-advisor Amova Asset Management, Inc. ("Amova"). KHYB is benchmarked to the JP Morgan Asia Credit Index (JACI) Non-Investment Grade Corporate Index. The fund provides exposure to USD-denominated high yield debt securities issued by companies in Asia.

Asia High Income Bond Market Features:

- The Asia Bond Market has witnessed steady growth over the last decade. The JP Morgan Asia Credit Index grew from a market capitalization of \$257 billion in 2010 to \$904 billion in December of 2024, an increase of 251%.¹
- The Asia high yield bond market currently offers higher yields than other global high yield bond markets. As of December 2024, Asia high yield bonds had a yield of 9.7% compared to 7.3% for US high yield bonds.²
- The default rate of Asia high-yield corporate bonds has been lower than that of high yield bonds in other emerging market regions in six of the past thirteen years and was lower than the US high yield default rate in both 2019 and 2020.¹

KHYB Features:

- Sub-advised by Amova. Amova was established in 1959 and is one of Asia's largest asset managers, with over \$200 billion in assets under management. Amova is a leader in Asia fixed income with 30+ years of experience in the market.³
- KHYB portfolio manager Wai Hoong Leong is supported by one of the largest Asia fixed income teams. His team uses top-down macro research and bottom-up credit research to construct the Fund's portfolio.

Definitions:

J.P. Morgan Asia Credit Index (JACI) Non-Investment Grade Corporate Index: consists of liquid US-dollar denominated debt instruments issued out of Asia ex-Japan. It is based on the composition and established methodology of the J.P. Morgan Asia Credit Index (JACI), which is market capitalization weighted. The index is limited to issuers classified as non-investment grade based on the middle rating between Moody's, Fitch, and S&P.

12-Month Distribution Rate: the distribution yield an investor would have received if they had held the fund over the last twelve months, assuming the most recent NAV. The 12-Month Distribution Rate is calculated by summing any income, capital gains and return of capital distributions over the past twelve months and dividing by the sum of the most recent NAV and any capital gain distributions made over the same period.

30-day SEC Yield: standard yield calculation developed by the U.S. Securities and Exchange Commission (SEC) that allows for fairer comparisons of bond funds. It is based on the most recent 30-day period covered by the fund's filings with the SEC. Option Premium is not included in the SEC yield calculation.

Brokerage commissions will reduce returns. Beginning 12/23/2020, market price returns are based on the official closing price of an ETF share or, if the official closing price isn't available, the midpoint between the national best bid and national best offer ("NBBO") as of the time the ETF calculates the current NAV per share. Prior to that date, market price returns were based on the midpoint between the Bid and Ask price. NAVs are calculated using prices as of 4:00 PM Eastern Time.
