The Index is designed to track the performance of companies engaged in the production of electric vehicles and/or their components, or engaged in other initiatives that may change the future of mobility. The Index includes issuers engaged in the electric vehicle production, autonomous driving, shared mobility, lithium and/or copper production, lithium-ion/lead acid batteries, hydrogen fuel cell manufacturing and/or electric infrastructure businesses.

## KARS Features:

- Access to global companies that operate in all areas of new transportation methods, passenger and freight, including electric vehicles, autonomous vehicles and shared mobility.
- Exposure to companies that lead the development of vehicle connectivity like Internet of Vehicles (IoV) and Intelligent Mobility.
- Exposure to the growth brought on by increased demand for lithium-ion battery and non-ferrous metals like lithium due to electric vehicle adoption.
- Exposure to equities listed in Mainland China, currently the world's largest electric vehicle market.

- 57% of new car sales and over 30% of the global car fleet are projected to be electric by 2040.<sup>1</sup>
- The global electric vehicle market is projected to command \$2.7 trillion of total investment before 2040.<sup>2</sup>
- Autonomous vehicles and the resulting “passenger economy” are projected to generate a cumulative \$8 trillion in global service revenues by 2050.<sup>3</sup>

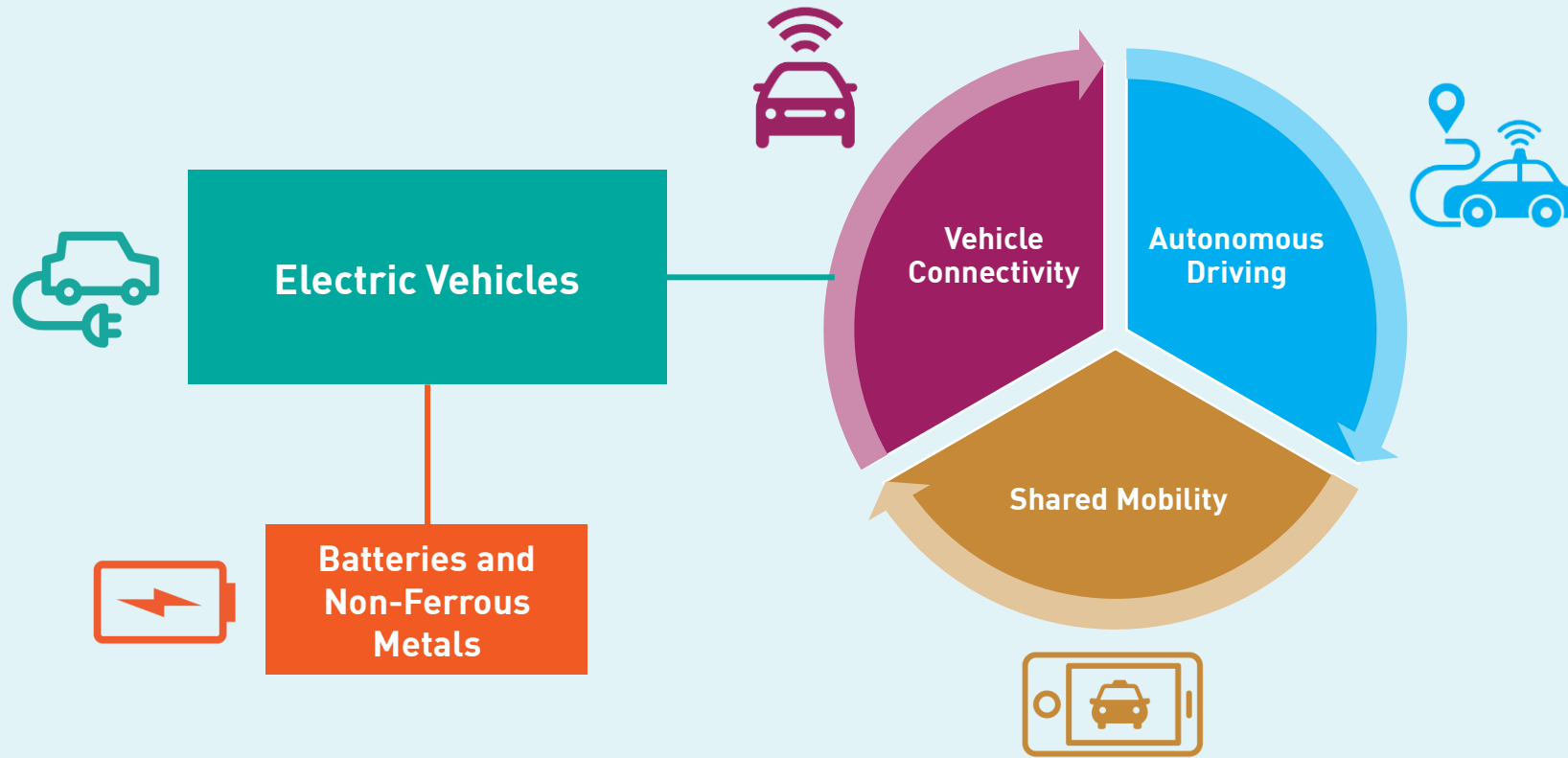

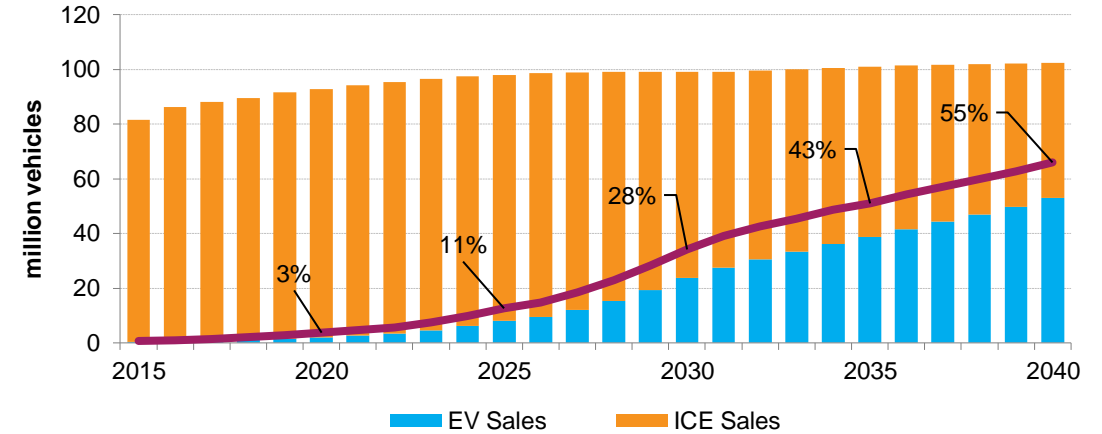




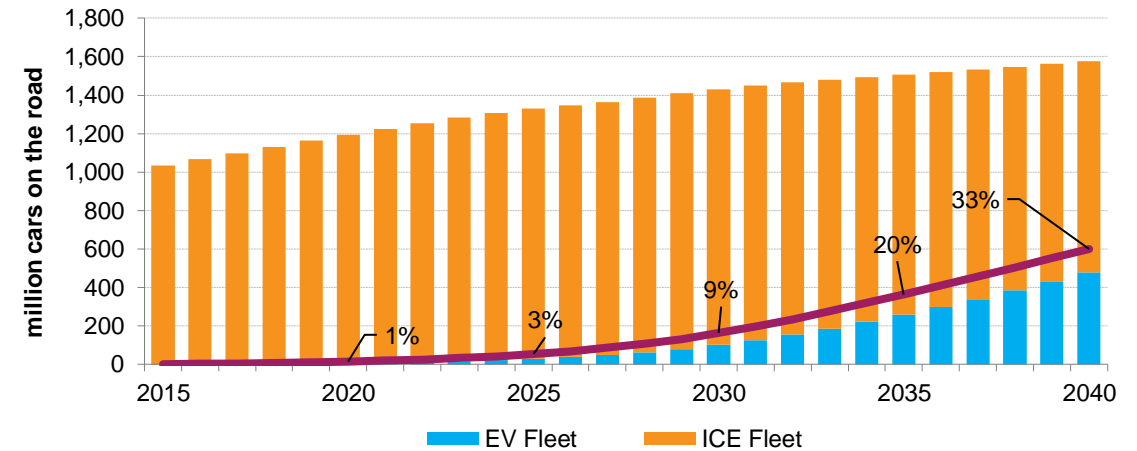
## Electric vehicles (EV) are becoming increasingly widespread and economical.

- 57% of new car sales and over 30% of the global car fleet are projected to be electric by 2040.<sup>1</sup>
- China is projected to account for nearly 50% of global EV sales in 2025.<sup>1</sup>
- Rising average mileage per vehicle brought on by ride sharing platforms may result in electric vehicles becoming more cost competitive than vehicles with traditional internal combustion engines (ICE).
- The low environmental impact of electric vehicles means that governments may be more motivated to manufacture them, and many have already introduced subsidies for electric vehicles.<sup>2</sup>

Global light duty vehicle fleet<sup>1</sup>

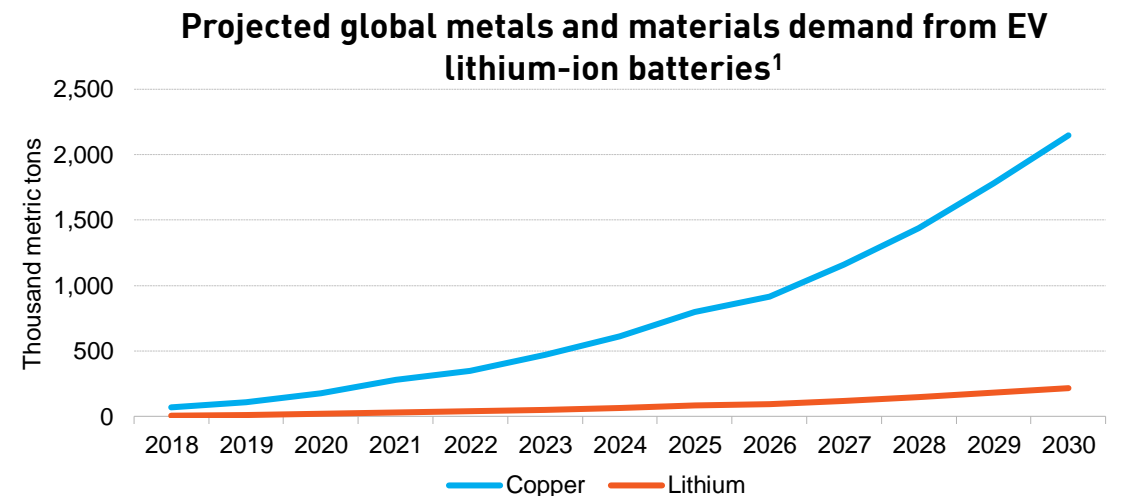
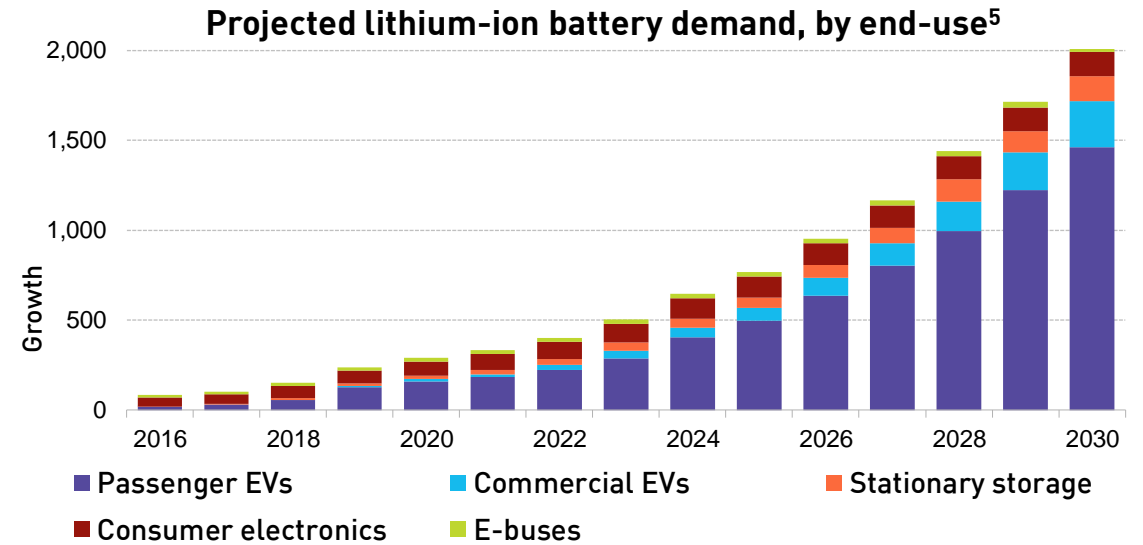

## Batteries and Non-Ferrous Metals are an ideal avenue for capturing the potential value of electric vehicle markets.

- Widespread adoption of electric vehicles may dramatically increase demand for lithium-ion battery and non-ferrous metals such as lithium and copper.
- Global lithium-ion battery demand is projected to grow 1829% by 2030.<sup>5</sup>
- The revenue pool for lithium, an indispensable component of electric vehicle batteries, is expected to grow 450% by 2025.<sup>2</sup>
- Copper demand for electric cars may rise nine-fold by 2027.<sup>3</sup>
- Mining companies have already begun to increase production capacity to meet the impending demand. Galaxy Resources recently purchased a mining area in South America's "Lithium Triangle," which is home to around 60 percent of the world's reserves.<sup>4</sup>

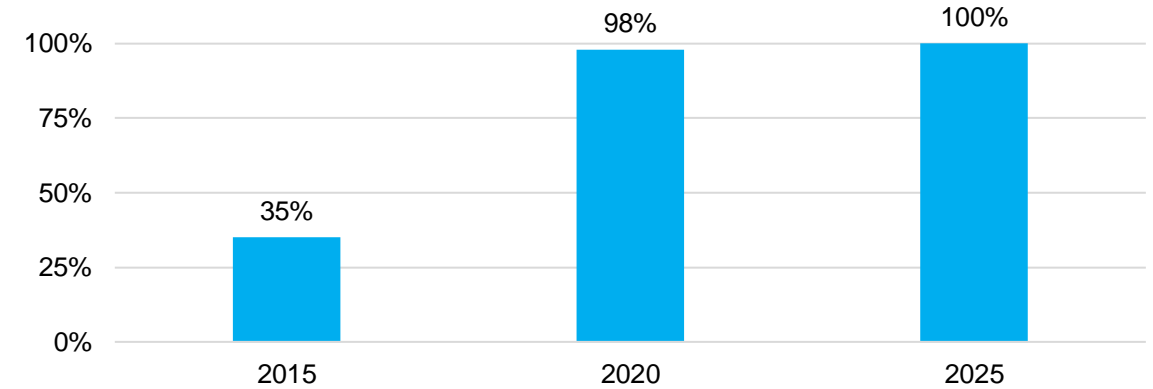

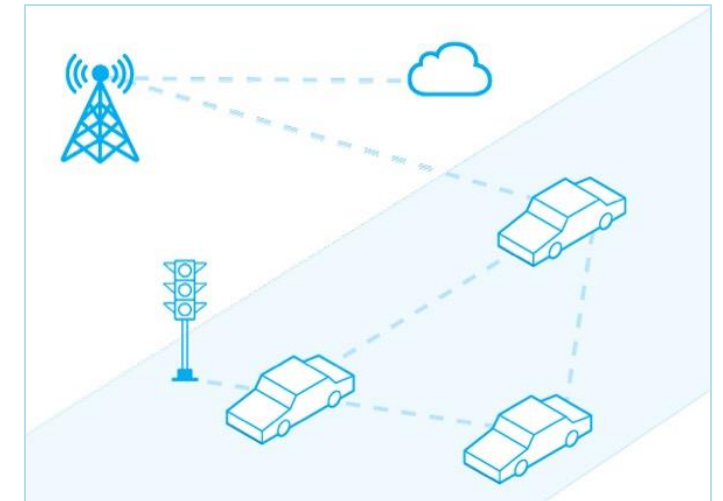
## Connectivity technology like Internet of Vehicles (IoV) connects cars to each other and outside world.

- Nearly all new vehicles sold in China, the European Union, and the United States are projected to be internet connected by 2022.<sup>1</sup>
- The growth of Internet of Vehicles (IoV) may potentially produce \$273 billion in revenue by 2026, according to a report by GSMA.<sup>2</sup>
- Companies like NVIDIA and NXP Semiconductor provide connectivity solutions including Artificial Intelligence (AI), Vehicle-to-Vehicle (V2V) and Vehicle-to-Everything (V2X).
- Connectivity in personal vehicles and all types of transport is projected to increase, creating a larger role for data services companies like Alphabet and Baidu in the mobility space.

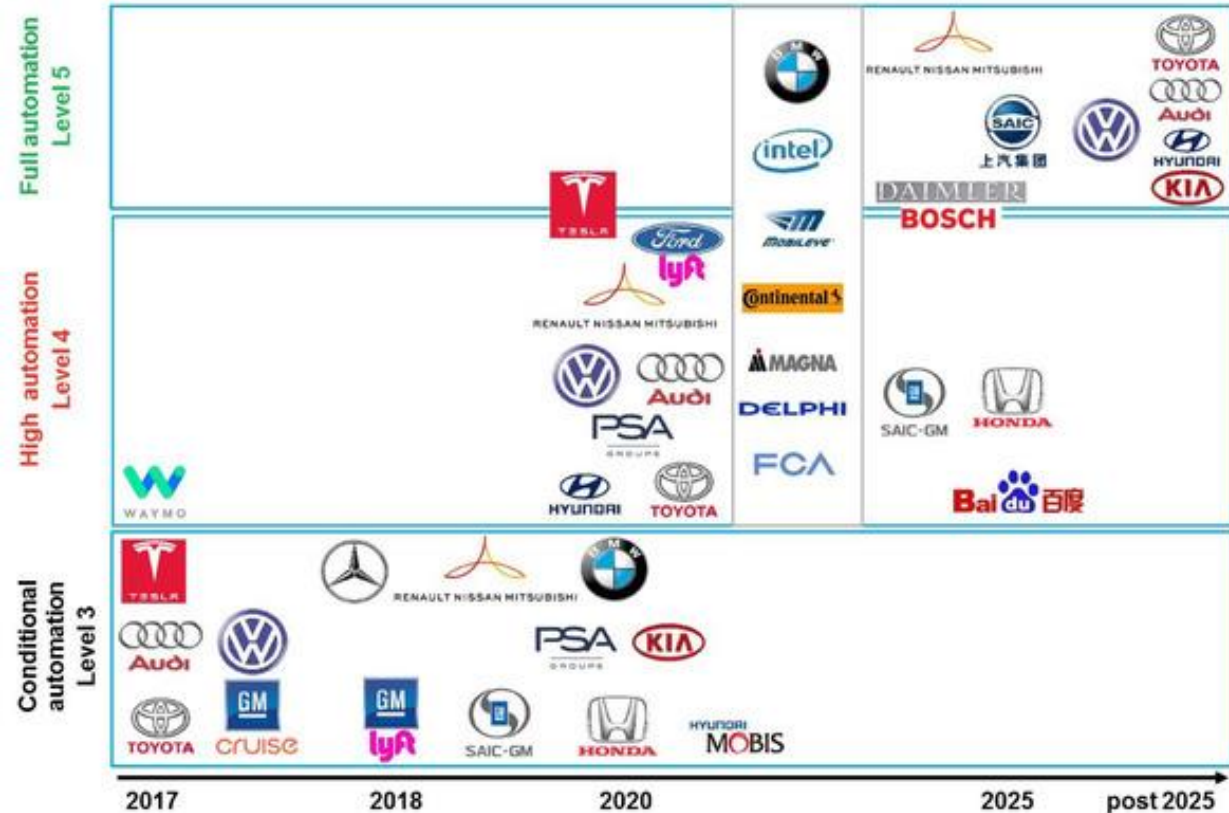




## Autonomous vehicles could dramatically change the nature of the transportation market.

- By 2035, cars with autonomous features are projected to capture 25% of the new car market and more than 30 million autonomous vehicles are projected to be sold per year globally.<sup>1</sup>
- The advanced driver assistance systems (ADAS) market, a precursor to full autonomy, will reach \$36 billion by 2024, from \$11 billion in 2019.<sup>2</sup>
- Alphabet’s Waymo has developed autonomous vehicle systems that are already being regularly used in California and Arizona and have amassed over 10 million “self-driven” miles.<sup>3</sup>
- Baidu’s Apollo Program is the first open source simulator for autonomous vehicle developers and has already partnered with over 100 partners including Nvidia and Infineon.<sup>4</sup>

### Autonomous vehicle launch timelines based on public announcements<sup>5</sup>



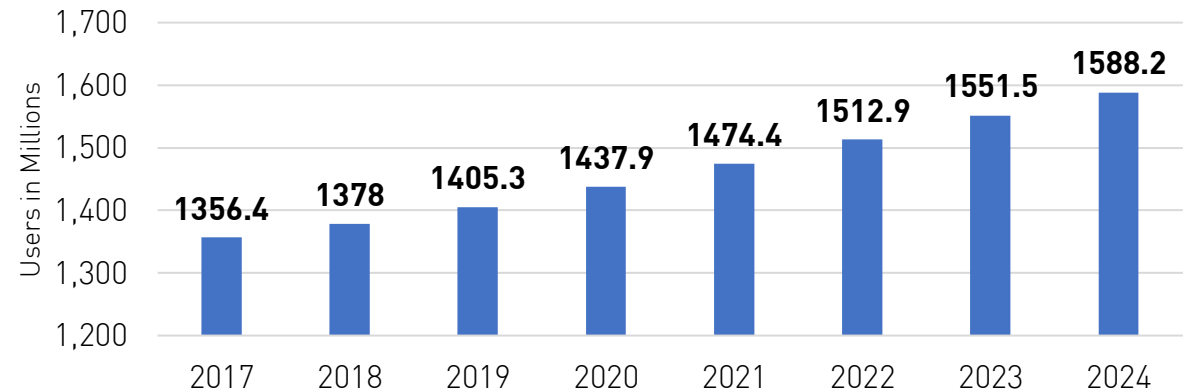

## Shared mobility is revolutionizing transport systems.

- The rapid rises of ride hailing platforms such as Uber laid the foundation for the major paradigm shift in transportation to a “passenger economy,” which is projected to add \$8 trillion to the global economy by 2050.<sup>1</sup>
- Ride hailing companies are capturing market share at an extremely fast pace. There are already over 736 million users of ride hailing platforms and that number is projected to increase to over 1.5 billion by 2023.<sup>2</sup>
- Car sharing platforms are also on the rise. These platforms allow users to rent and drive a car for short periods of time. Examples include Baidu’s Pand-auto, GM’s Maven, Daimler’s Car2Go, and BMW’s ReachNow.
- Baidu’s Pand-auto has the world’s first fully electric fleet of shared mobility vehicles. The company has over 15,000 electric cars and over 2,100,000 registered users as of Nov 2017.<sup>3</sup>
- The combined trend of Shared Mobility and Autonomous driving has the potential to disrupt vehicle ownership and insurance as transportation becomes a pay as you go service in many cases.<sup>4</sup>



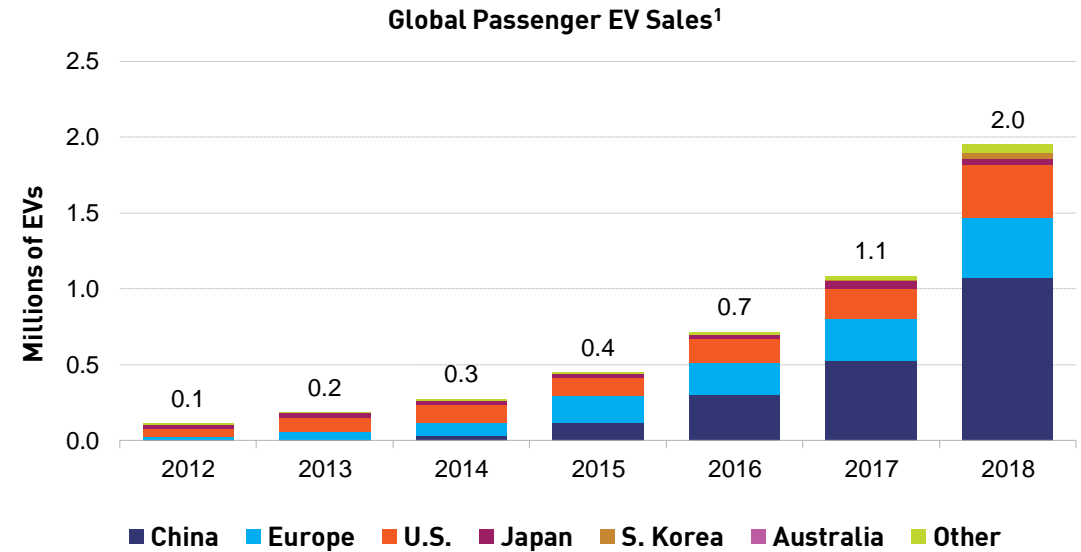
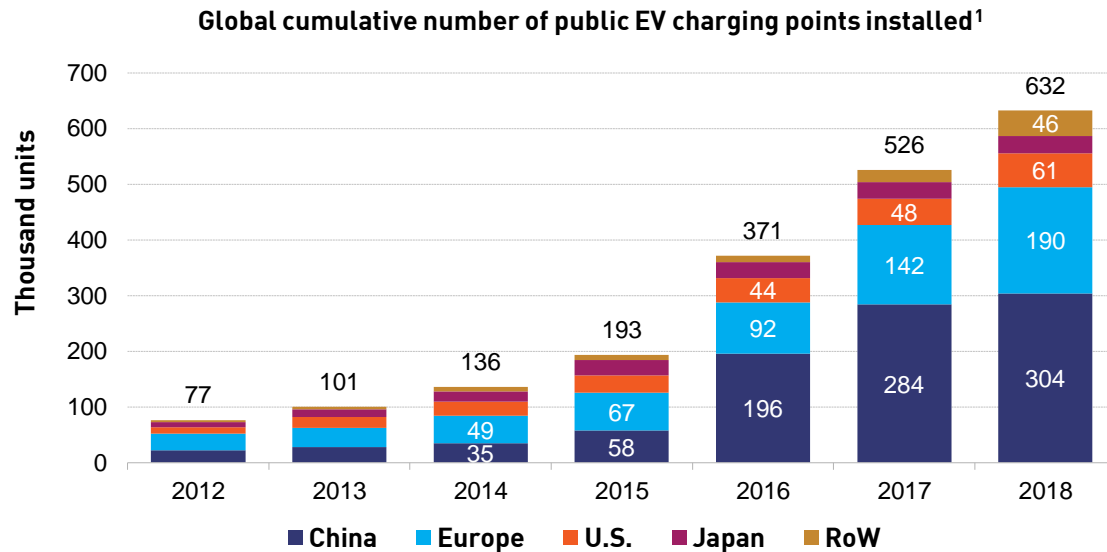
Ride Hailing Platform User Projections<sup>4</sup>

## China possesses unique advantages in future mobility development.

- China is the world’s largest electric vehicle (EV) market with nearly 1.1 million EV sold in 2018.<sup>2</sup>
- China has already built 401,000 public charging stations<sup>4</sup> compared to only 20,000 in the US.<sup>5</sup>
- The Chinese government already offers subsidies of \$3,500 per EV with a range of over 400 km to buyers.
- China’s urban development provides an opportunity to build exterior infrastructure for autonomous vehicles from the ground up.

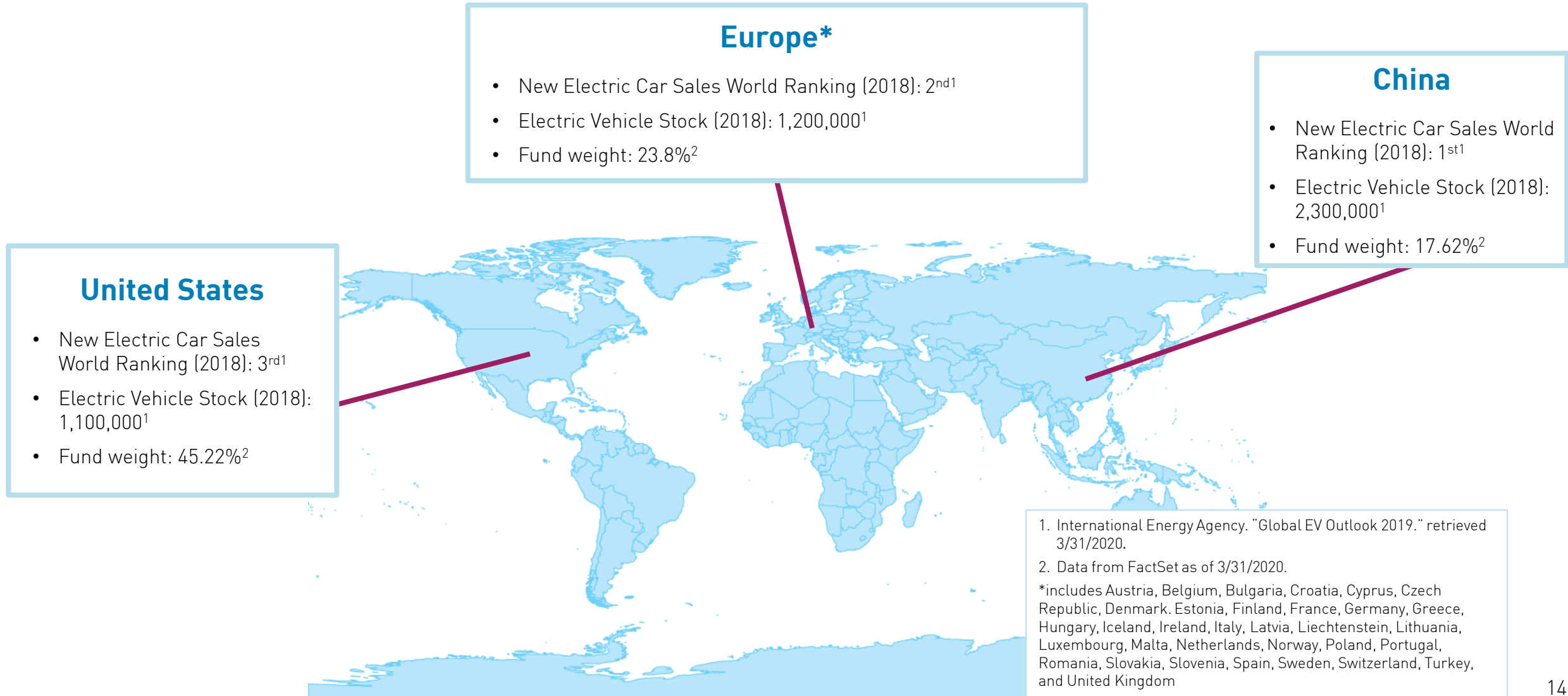

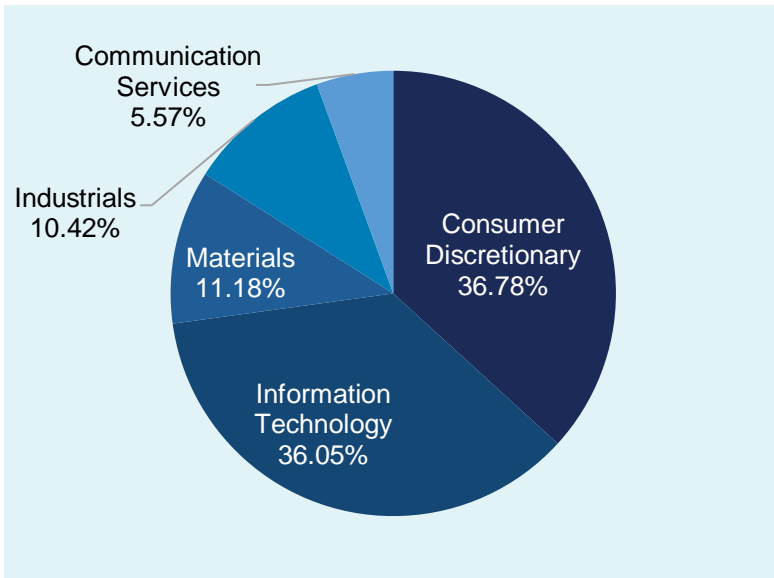

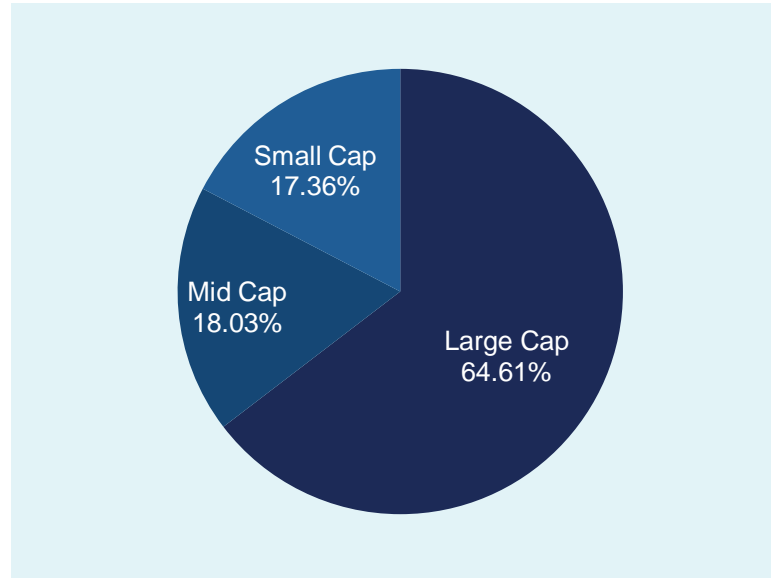

### KARS Sector Breakdown



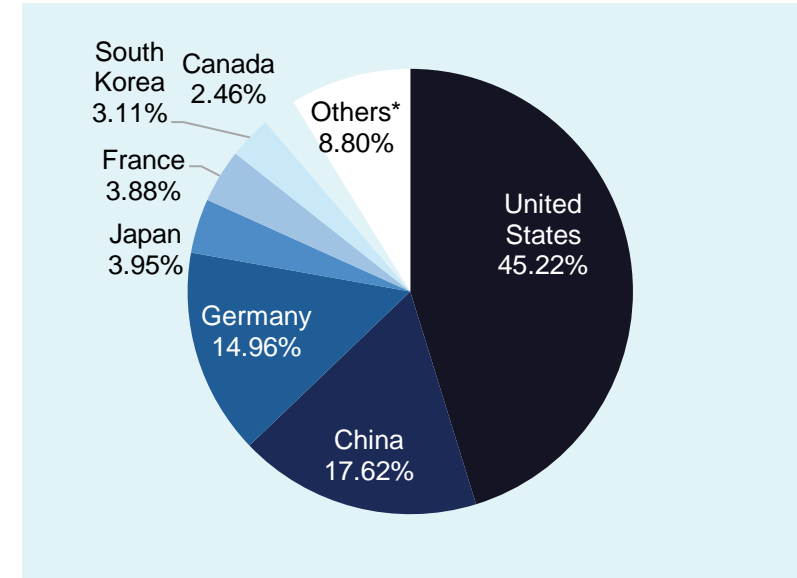
